

**'FATHER'S DAY' FACEBOOK PROMOTION**  
**TERMS AND CONDITIONS**

1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The Promoter is AMP Capital Shopping Centres Pty Ltd - Centre City Shopping Centre, 11 Gill Street, New Plymouth. All personal information will be collected and stored by the Promoter in accordance with the Privacy Act 1993. You have the right to access your personal information and request correct of any errors in it pursuant to the Privacy Act 1993. The Promoter may use entrant's personal information from entries to conduct the promotion.
3. Entry is only open to New Zealand residents. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering this promotion.
4. Employees (and their immediate families) of the Promoter, Centre City Shopping Centre, tenants and their employees of the promoter and agencies associated with this promotion are ineligible to enter.
